# RECREATIONAL FISHING LICENSES - SEA AND BRACKISH WATERS

## FOR RECREATIONAL FISHING IN PORTUGAL YOU NEED A FISHING LICENSE

### LICENSES AND FEES

**APEADA:** exclusively for fishing from shore;

**EMBARCADA:** for fishing from shore and on board of recreational vessels.

**SUBMARINA:** exclusively for underwater fishing;

**LÚDICA GERAL:** for fishing from shore , on board of recreational vessels or underwater.

## HOW TO GET A RECREATIONAL FISHING LICENCE

### ATM

**Only for National Citizens**, who have an Identity card - Cartão de Cidadão (CC) or Bilhete de Identidade (BI) - you will need to:

- Chose the type of license you want
- Insert the number of your identity card (CC or BI)
- Insert the number of your mobile phone.

## DEMATERIALIZATION OF RECREATIONAL FISHING LICENSES

### HOW IT WORKS

- In order to fish, the recreational fisherman just needs to carry the **identification document** referred to in the license.
- The recreational fisherman receives an SMS **confirming the activation** of the license and respective data.
- The recreational fisherman is **informed** by SMS when the license is **about to expire**.
- The recreational fisherman can **consult all the license data** at any moment (nº of license, nº of the identification document, type and validity ) by sending an SMS from the mobile registered in the license with the text **UPLUD**, to the number (+351)925507447.
- The central authorities may consult registered data in recreational fishing licenses in the DGRM data base at any moment.
